CONSENT AND REGISTRATION FORM

Name of Young Cricketer: _____

1. All cricketers will wear a helmet, as supplied by the club, when either batting or keeping wicket. It is recommended that an abdominal protector and gum shield be worn (to be supplied by player).
2. The club is working towards adopting codes of conduct for all coaches, officials and volunteers working with young people.
3. The club expects that young people behave to an acceptable standard during all training sessions and at matches. In the event of persistent unacceptable behaviour, parents will be contacted. **Please read and sign separate code of conduct.**
4. The club is working towards policies laid down by the Child Protection Act.
5. In the event of an accident or emergency you will be contacted. If we are unable to contact you the coach will act in loco parentis. If necessary, your child will be accompanied to hospital and the club will contact you at the earliest possible time. On contact, the club would expect parents to relieve the coach.
6. While the club has Public Liability Insurance it does not insure, at any level against injury to players. If you wish your child to be insured you are advised to take independent insurance.
7. All young cricketers will remain at the ground until the end of the training session on training nights, unless the club receives a written request from parents to the contrary. (So that you and the club knows where your child is.) Membership cards must be handed in and collected on departure.
8. On a training evening at least one person, who holds a first aid certificate or have attended a child protection course, will be present.
9. Permission for the use of photographs and recorded images:

Please note that this part of the form needs to be signed by the Young Player (if aged between 12 and 18) as well as by the Parent or Legal Guardian of the Young Player.

Halstead Colts Cricket Club recognises the need to ensure the welfare and safety of all Young People in Cricket. As part of this commitment we will not permit photographs, video images or other images of Young People to be taken or used without the consent of the Parent/Guardian and the Young Player. Halstead Colts Cricket Club follow the guidance issued in 'Safe Hands – Welfare of Young People in Cricket' on the use of images of Young People which is available at <http://www.ecb.co.uk/safehands>. Halstead Colts Cricket Club will take steps to ensure that these images are used solely for the purpose they are intended, which is the promotion and celebration of cricketing activities.

If photographs e.g. team or action shots, are submitted to the Press or published on Halstead Colts Cricket Club website or in our handbook individuals will not ordinarily be identified. Where a child or young person is identified it will only be with the explicit consent of parents.

Please note: Halstead Colts Cricket Club understands that there are circumstances under which a parent would not wish their child to be photographed. Whilst Halstead Colts Cricket Club will do all that it can to ensure the safety of children during photographed events, it is the responsibility of the parent concerned to ensure that if their child is not to be photographed and partakes in an activity and is by the nature of the activity inadvertently photographed or filmed, Halstead Colts Cricket Club cannot be held responsible.

10. Transport to matches and practice sessions

Halstead Colts Cricket Club policy is that parents or other responsible adults are responsible for transporting players to and from all matches and practice sessions and therefore the Club will not be registering Private Vehicles for the transportation of individuals in connection with any fixtures or practice sessions arranged by the Club. The implementation of this policy is not intended to exclude any player from participation and parents or guardians should contact the Club Welfare Officer if they have any problems with the transportation of players to matches or practice sessions.

11. Club Changing Policy

For players under the age of 16 playing in adult teams the following policy applies:

Young players uncomfortable with changing or showering with adults are under no obligation to do so and are advised to change and shower at home

Parental consent must be given if Young Players are to share changing facilities with adults

If Young Players are sharing changing facilities with adults, parents have the option to supervise them whilst they are changing. The Club will make reasonable efforts to arrange this.

Consent by Parent/Legal Guardian - Please strike out the words, which you do not agree to.
